Puppy/Adult must be paid in full 3 weeks prior to 8 week old birthday, in the case of adult, 3 weeks prior the shipping date.

We reserve the right to refuse adoption/purchase.

If your chosen puppy is no longer available due to unforeseen circumstances, you will be offered another puppy of your choice, at market value.

Your deposits and all payments will be applied, If no puppy is available, deposits will be applied to next litters. No refund will be issued.

The puppy/ adult you are purchasing is a house pet, not an outdoor pet, and not should be left outdoors for long periods.

Breeder reserves first pick of any litter regardless of your pick of litter. This does not mean Breeder will take pick , it just serves to document Breeder reserves the right to exert the right should she choose to. _____intl

List applicants will be accepted / approved on a first come basis, and your name placed on the appropriate list in the order approved.
